## What's covered?

This course delivers an essential overview of environmental legislation affecting Irish organisations, with a focus on key regulations and how they are applied.

- EC (Control of Major Accident Hazards Involving Dangerous Substances) Regulations 2006
- Access to Information on the Environment Regulation (2007 & amendment regulation 2011)
- Protection of the Environment Act, 2003
- Carriage of Dangerous Goods by Road Act, 1998 and Regulations, 2011
- REACH/CLP Regulations
- Energy/Product Stewardship
- Energy legislation, including European Community (EPB) Regulations
- Safety, Health & Welfare at Work Act, 2005

## Who should participate?

This course is intended for those who are responsible for environmental management or compliance within their organisation. It is particularly relevant for:

- Team members involved in the maintenance or implementation of Environmental Management Systems (EMS)
- Managers and supervisors overseeing emissions, waste and environmental performance
