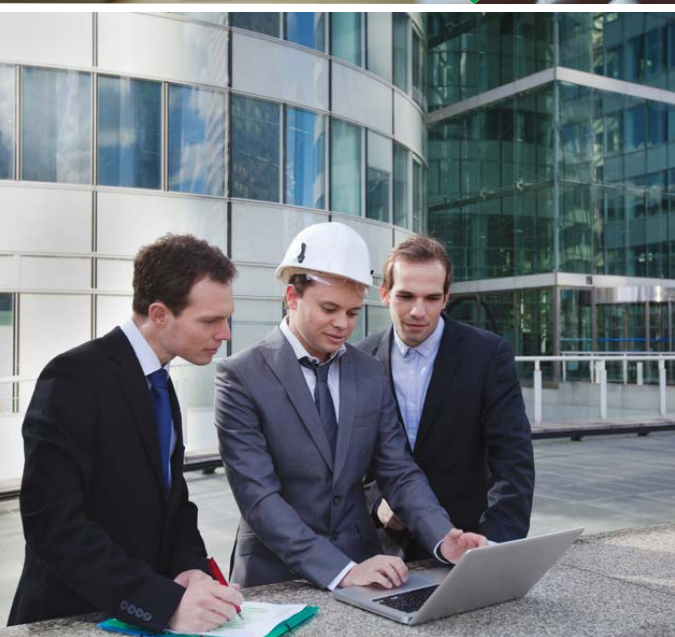

The Safety, Health and Welfare at Work (Construction) Regulations 2013 introduced significant changes to how construction safety is managed in Ireland. These regulations affect all construction projects and place clear legal obligations on duty-holders including clients, designers, contractors and project supervisors.
