What's covered?

- Scope, exemptions, exceptions and registration requirements
- Overview of the registration process and roles of lead/member registrants
- Candidate List and Substances of Very High Concern (SVHCs)
- Introduction to CLP regulation and its connection to GHS
- Notifying, classification and labelling of substances to ECHA, online submission in REACH-IT
- CLP Notification - Submit substance data to ECHA using REACH-IT
- Safety Data Sheets (SDS): format, layout and extended SDSs
- Supply obligations and updates to REACH Annex II
